For employing an international student graduate,

Once they have completed their qualification, most international student graduates are eligible for a 7, 2, or 3 year **Post-study work visa**. This gives them a chance to get valuable New Zealand work experience after completing their studies.

Most student visa holders are able to work parttime (up to 20 hours per week) while they are studying and full-time during scheduled semester breaks and/or over summer vacation.

Working

Can I work while I am studying?

Most international students can work *up to* **20 hours a week** and full-time during scheduled course breaks. It is a great way to get work experience, earn some extra spending money, and meet new people.

You need to make sure that your visa allows you to work, and make sure you leave yourself time to study and enjoy New Zealand.

Can I work after I graduate?

If you want to stay in New Zealand after you graduate, you can apply for a *Post-study work visa*. This visa lets you work for almost any employer in New Zealand, so you can get valuable practical work experience.

The length of Post-study work visa you are eligible for will depend on the New Zealand qualification you have completed.

Finding a job

How can I find a skilled job?

If you want to continue working in New Zealand after your Post-study work visa, you will need a skilled job. It is important to know that there may be plenty of competition for these jobs from both international and domestic students so make sure you present yourself well to prospective employers.

The process of getting a job in New Zealand can be different from what you are used to. New Zealand employers may prefer CVs in a different style, and job interviews may be more informal.

Information you can provide prospective employers

Applying for a visa

How do I apply for a Post-study work visa?

The easiest and fastest way to apply for a visa is online. Visit immigration.govt.nz/apply to start your visa application.



f you plan to apply for a Post-study work visa, you must apply within 3 months of the expiry date of your Student visa or within 6 months if your qualification was a PhD.

Information we need

To apply for a Post-study work visa, we need:

- a scan of your passport (if you are applying
- evidence of your completed qualification
- proof that you have \$4,200 available to pay your living costs while you are looking for a job (eg bank statements in your name)
- documents that show you meet the Health requirements. (You might need to have a medical examination – go to immigration. govt.nz/healthevidence)
- documents that show you meet the Character requirements. (You may need to provide updated police certificates).



Your rights as a worker

What are my work rights?

International students and graduates have exactly the same rights as all other New Zealand workers and must be treated fairly. Your employer must:

- give you a written employment agreement
- pay you at least the minimum wage
- pay you for all public holidays that you would normally work, or extra pay when you work on a public holiday
- pay you for sick leave and annual leave entitlements.

If you believe your employer is not meeting these standards, call the Employment New Zealand phone line on **0800 20 90 20** (ask for the "Language Line" if you need an interpreter).

Working during and after your studies in New Zealand

	While you are studying Student visa	After your studies Post-study work visa	Next steps
Eligibility and entitlement	Most international students studying in New Zealand are allowed to work while they study. You may be able to work for up to 20 hours per week while studying and/or full-time during scheduled vacations. You must work for an employer and have an employment agreement. You cannot be self-employed or provide commercial sexual services.	 You can apply for a Post-study work visa if you have gained: a qualification at level 7 or higher on the NZQF* and you have studied it in New Zealand for at least 30 weeks, OR a qualification at levels 4-6 on the NZQF* and you have studied it in New Zealand for at least 60 weeks, OR 2 qualifications at levels 4-6 on the NZQF* (the second qualification being at a higher level) and you have studied each qualification for at least 30 weeks (60 weeks in total). Your Post-study work visa will be valid for 1, 2, or 3 years, depending on your qualifications. You can work for almost any employer but cannot provide commercial sexual services, or operate or invest in a business that does. 	Your chances of getting a further temporary work visa or residence visa depend on a number of things. These include whether your skills and/or qualifications are needed in New Zealand.
Tips	It is a good idea to get work experience related to your field of study during this time. This may make it easier to find work in that field after you graduate. Careers.govt.nz offers Work Connect, a free programme for international student graduates (level 7 and above) to help you prepare for the New Zealand job market.	You may be eligible for a temporary or a residence visa.
